## Message from the President

What happens when like-minded organizations and dedicated community members come together over water, wildlife, and recreation interests? The successful campaign to conserve 2,000+ acres in the Merrymeeting Lake watershed and create the new Birch Ridge Community Forest.

This treasured property has been a local and regional priority for conservation for over a decade. On June 28, the purchase of Birch Ridge by Southeast Land Trust and Moose Mountain Regional Greenways finally will make conservation of the land a reality. This is the **BIG STORY** for 2019, and many chapters led up to this happy ending.

After the sudden sale of this huge parcel to a logging company in August 2017, Russ Weldon set the wheels in motion for a second attempt by the MMLA to purchase the land. With full backing from the Board, Russ and Mark Sullivan met with the new property owner and came away with a verbal agreement. The required deposit was secured by a small group of lake residents, and a signed purchase agreement soon was in place.

Given the need for both quick action and expertise in putting land into permanent conservation, the Merrymeeting Lake Association entered into a partnership with Southeast Land Trust (SELT) and Moose Mountain Regional Greenways (MMRG). The funding campaign to raise \$2,950,000 through public grants and private gifts quickly got underway, and the goal was reached in record time.

On behalf of the Merrymeeting Lake Association, I thank everyone who donated to this important conservation effort. In addition to helping reach the funding goal, your financial backing demonstrated significant community support and involvement, which was a determining factor or at least a consideration in the grant awards received from the U.S. Forest Service, NHDES Aquatic Resources Mitigation Funds, and NH Land and Community Heritage Investment Program.

About our partners, I can't say enough about the expertise and resources brought to the effort by SELT and MMRG. It was their professional leadership that enabled the MMLA to succeed in its initiative to place Birch Ridge into conservation for the next generations to enjoy. Be sure to read the article on the adjoining page that talks about all the exciting future uses of the land by the public.

On a personal note, I regretfully have informed the Board that I will not be able to complete my two-year term as president due to family issues. It's been rewarding to work with the directors and so many volunteers to grow and strengthen the MMLA. Your support has resulted in a strong, vibrant association that is committed to preserving Merrymeeting Lake for generations to come. The question always will be: If we don't protect the lake, who will?

Bill Bassett President, MMLA Now that clean water, wildlife, and recreation are here to stay, the focus turns to the new public forest itself - and the exciting opportunities for use by area residents and visitors.

For months, a Steering Committee of more than 20 volunteer community members and partners has been hard at work, bringing a variety of unique perspectives to the discussions about the future of this special place. In November, a community visioning session was held with 70+ people in attendance. Participants enthusiastically shared ideas about the future of the landscape and discussed topics ranging from trails and wildlife to educational opportunities and uses for the property's ridge-top cabin. A community survey also was mailed to New Durham residents and property owners to provide further input to the committee as it continues to map out a comprehensive plan.



To introduce people to this beautiful property, a variety of activities and hikes already have been offered. Among them, MMRG led "Hawks and Walks," a guided hawk watch, as well as "Fungi Foray-Mushrooms at Merrymeeting," a hike to Caverly Mountain.

Birch Ridge is a haven for wildlife with a diverse range of habitats from ridge tops to wetlands. There are numerous streams, a 25-acre beaver pond, more than 30 vernal pools, and Coldrain Pond for fly fishing.

Recreational opportunities abound. Miles of hiking and cross-country ski trails will be enhanced by kiosks and trail maps. Snowmobile enthusiasts know the property well, as it includes Corridor 22, the main east-west snowmobile trail connecting Maine to central NH. The land also is a popular destination for archery and firearm hunters, as the predominantly oak and hickory forest provides food sources for a variety of wildlife.


As you look to the ridge this summer, you'll see the landscape beginning to green as it fills in with new growth. The year before the timber harvesting began was a good mast year, and oak seedlings abound. Wildlife also is making its way back into the cleared areas. We all can be proud of the New Durham community and our partner organizations for working together to create the Birch Ridge Community Forest through permanent land conservation.

# Fireworks up in the Air

Since last season, the MMLA Board of Directors has taken steps to ensure that the Association's liability insurance policies provide adequate coverage for its directors and all of its activities. As part of that process, the MMLA's insurance policies have been moved to a different insurance broker/agent.

The new broker/agent has informed us that the MMLA's liability coverage did not and cannot extend to the association's co-sponsorship of and/or financial contribution to the Independence Day fireworks display as put on by the Merrymeeting Marina staff each year.

Since the Board of Directors also has been unable to obtain any alternative liability coverage relative to any involvement by the MMLA in the Marina's annual fireworks display, the association no longer will be able to co-sponsor or financially support this event.

For the show to go on, the Merrymeeting Marina has offered to match, dollar for dollar, all individual donations to a fireworks fund. Lake residents who want fireworks again this summer are encouraged to stop by the Marina and make a contribution.

## Merrymeeting Lake Clarity and Quality Among New Hampshire's Best

Pristine, clean, and clear are three words frequently used to describe Merrymeeting Lake. In fact, this beautiful gem of a lake consistently ranks in the top two or three cleanest lakes in the state.

For more than three decades, a dedicated MMLA volunteer team has headed out by boat on a weekly basis to take water samples from several places around the lake. These volunteers are part of the New Hampshire Lay Lakes Monitoring Program, which is affiliated with the UNH Center for Freshwater Biology. Results are shared with the MMLA community at the annual meeting in July and also can be found at mmlake.org.



This year, the MMLA Water Quality Team will be paying particular attention to any effects from the logging of the 2000-acre Birch Ridge property. Although the impact of this activity on the lake is being monitored carefully by the state, these volunteers will be able to make their own determination once they begin testing in May.


What is the importance of keeping Merrymeeting Lake so clean and pristine? Obvious reasons would include natural beauty, recreational value, and a healthy habitat for fish and wildlife. However, many studies also have determined that water clarity directly impacts the value of properties surrounding a lake. For each three-foot loss of water clarity, property values can fall up to 20%.

What are some of greatest detriments to maintaining water clarity and quality? Use of fertilizers on lawns and plants, failure to maintain or replace old septic systems, and run-off from the reduction of natural shoreline vegetation all are high on the list.

How can you help? The MMLA Preserve and Protect Committee recently completed and distributed a booklet entitled, 20 Ways To Protect Merrymeeting Lake: How We Can Preserve The Lake We Love. Look for the online link at mmlake.org or pick up a copy at the annual meeting. With everyone working together, Merrymeeting Lake will remain clean, clear, and pristine.

# Lake Host Program Continues To Prove Its Worth

Each year Lake Host Inspectors at the public boat launch perform courtesy boat inspections to keep invasive species from entering Merrymeeting Lake. This important program is funded by your membership dues and donations to the Water Quality Fund along with a small grant from NH Lakes that administers the program statewide. It is the first line of defense in the battle to keep Merrymeeting Lake free of invasive plants and animals.

Last year, MML's dedicated lake hosts recorded 1,772 boat inspections and removed 12 samples of plant life from watercraft and equipment. All were sent to the lab for testing. *One sample, confirmed by the lab as an invasive species, was removed from the boat before it was launched into our lake!* 

Statewide, more than 25 "saves" were made as lake hosts worked to keep aquatic invasive species from entering New Hampshire's lakes. Of those saves, eight occurred on waterbodies (Merrymeeting included) that are not known to contain AIS infestations.

Coverage at the launch this summer is planned as follows: • late May to mid/late June – weekends 7:00 a.m. to 5:00 p.m. • mid to late June until late August – weekdays 7:00 a.m. to 5:00 p.m. and weekends 7:00 a.m. to 7:00 p.m. • Fridays during busiest summer weeks – 7:00 p.m. time extension • last week in August through Labor Day – weekends 7:00 a.m. to 7:00 p.m.

Volunteers are needed to man the boat launch for a few hours on weekends in June until all of the paid lake hosts return for the summer and again in September after they've returned to school. # Merrymeeting Lake New Hampshire's One Millionth Boat Inspection Winner

The NH LAKES Lake Host program has been conducting courtesy boat inspections to prevent the spread of aquatic invasive species since 2002. This program reached one million inspections last summer. To celebrate, NH LAKES randomly selected a participating boater and Lake Host program to receive a prize as the official one millionth inspection!

Sara Kowalski, long-time lake host and program manager, thought she was participating in a promotional video. While doing a routine boat inspection for the video, Sara found and read the announcement that Merrymeeting Lake had won.

# Loon Preservation Committee's Annual Loon Census on Saturday, July 20

The eight volunteers who officially counted loons on Merrymeeting Lake last summer were rewarded with eight beautiful sightings - five adults and three chicks. Sadly enough, despite such promising starts, none of the chicks survived. One reportedly was attacked by an eagle, and the other two were trapped by the early winter ice.

But there still is hope! Come summer, loons on MML will have another chance to build nests and raise chicks. And their presence/ activity will be observed by teams of boaters participating in the 2019 Annual Loon Census on Saturday, July 20, from 8:00 to 9:00 a.m. Aside from enjoying a peaceful morning cruise, volunteers will report valuable data to help the Loon Preservation Committee better understand and protect the loon population throughout New Hampshire.

### Good News for New Hampshire's Loon Population Lead Tackle Buyback Program Expanded

The lead tackle buyback pilot program, conducted last summer by the Loon Preservation Committee (LPC) and NH Fish and Game, collected 4,786 individual pieces and 29 pounds of lead fishing tackle. This was a huge success since every single piece of lead tackle taken out of circulation has the potential to save a loon.

But there's more work to do. Nearly three years after the ban on the sale and freshwater use of lead sinkers and jigs weighing one ounce or less went into effect, the LPC has seen no reduction in the number of loon deaths from lead poisoning. Many tackle boxes still contain illegal fishing tackle purchased previously, which anglers easily can use by mistake. That's why the lead tackle buyback program is being expanded this summer from two participating retailers to an additional 10 stores.

Unlike many bird species, loons do not have separate dress codes for males and females. Interestingly, they have identical, not just similar, black-and-white breeding plumage, which makes one loon just as beautiful as the next.


